How is a training programme assessed?

We conduct a rigorous seven-stage process that includes on-site visits, interviews and reviews of documentary evidence.

Successful providers will need to meet standards across these four domains:

- · Ethics and values
- Health sector engagement/awareness
- Learning excellence
- Effectiveness of quality assurance arrangements

The Quality Mark is awarded to an organisation for all of their programmes of learning delivered to the health sector, so employers can rest assured that programmes of learning are fit for purpose.
